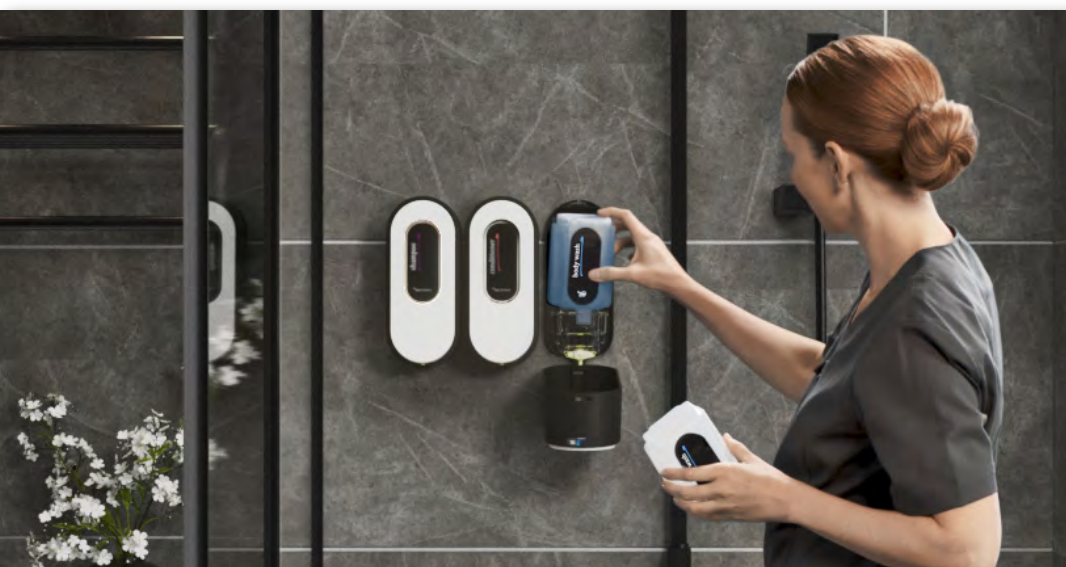

How to get your rebate:

- DSR to register and submit Proof-of-Sale* documents at <https://rapid-rebates.com/DialHenkel/> no later than May 31st, 2024.
- Receive your rebate check in the mail 6-8 weeks after submission for delivery.

*Proof-of-Sale requirements:

All Proof-of-Sale must be system generated documents from the distributor, such as an invoice or summary report by DSR and have the following printed on the document(s): Company Purchased From (Distributor), Company Sold To (End User), Purchase Date (Including the year), and listing of products with Part Number, Description, Size/Case Count, and quantity sold. Must be sold in full case quantities and have equal quantity of Dispensers and Refills sold to the end user. Submission amount and back up provided must be consistent, multiple invoices / end users acceptable. Each submission payment is limited to one DSR.

Promotional requirements:

- Proof-of-Sale* must be dated between 12/1/2023 and 4/30/2024 and include all information noted in POS requirements.
- Rebates must be submitted by 5/31/2024 or they will not be accepted.
- Maximum rebate payout is \$12,000 or 2400 Dispensers & Refill Placements per DSR.
- Minimum rebate payout is \$150 for 30 Dispensers & Refill Placements per DSR.
