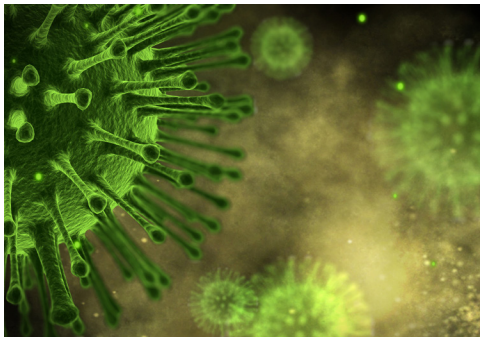

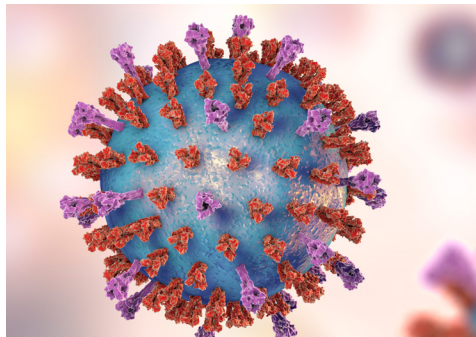

Pathogens to Watch Out For This Season



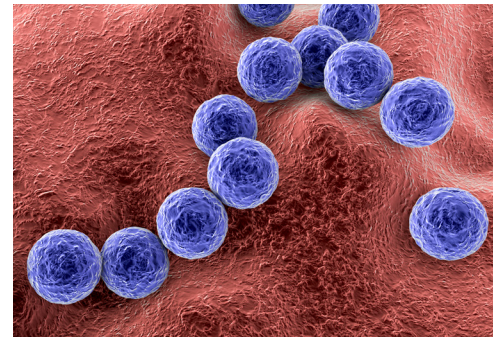
Influenza ("flu")

- ▶ Each year, 5-20% of people in the U.S. will become infected with influenza.¹
- ▶ Influenza results in up to 111 million missed workdays annually, an estimated 7 billion dollars in sick days and lost productivity.²



Respiratory Syncytial Virus (RSV)

Group A Strep
